PROGRAMS

AACR2 Study Group. Tom Cohn reported that the 3rd meeting of the group took place on September 27th. There were seven attendees, and the discussion focused on the chapter on continuing resources (serials). There was also a lot of freewheeling discussion on participants' real-world cataloging dilemmas, and on the suggestion of Michael Aloi, it was decided for to ask folks to make a note of cataloging problems they have been

having and bring them to next meeting. We will then inquire as to what AACR2 would have to say.

Since the last scheduled meeting of the group will be Nov. 16th, Tom raised the question of the future of the group. Might it morph into a more general Cataloger's Study Group or CATS Study Group? Possible topics would be LC subject headings, FRBR, etc.

Tech Services Annual Forum

Renee Capitanio reported that 46 people have signed up for the Technical Services Open Forum to be held on Oct. 19th at Sachem library. There will be demos of Catalogers Desktop and WebDewey, and an open discussion of issues of current concern to Technical Services departments.

Annual Meeting: Spyware, Scams, Viruses, Identity Theft

Michael Aloi reported that he was still trying to confirm with Detective Shrier of the Suffolk County District Attorney's office. Joyce Bogin will speak to someone from CBW Security. Min Liu recommended a company named Third Alternative. SCLA

Ted Gutmann reported on the latest SCLA meeting. He said SCLA has been more successful of late in recruiting candidates to run for positions, and there is a contested presidential election.

Possible Future Meetings

Three possible topics were discussed: (1) Legal aspects of computer use in libraries, (2) RSS feeds, and (3) using open source coding, e.g., XML, for library websites.

Tom Cohn stated that the deadline for submission of articles for the next issue is Oct. 31st. He recommended that future issues no longer be designated "Fall" and "Spring" but rather "Fall/Winter" and "Spring/Summer." The newsletter publishes biannually, and such a change might help to lengthen its "shelf-life."
