Resource Description & Access: A Cataloging Code for a New Millennium

Resource Description & Access (RDA) succeeds the Anglo-American Cataloging Rules, 2nd edition, revised, as the industry wide standard for cataloging. It is aptly named, as the mission of catalogers after all is to take the raw materials of a library collection and describe them in a manner that differentiates them from other materials, and makes them retrievable by author, subject access title and points. Among the changes are the following: Gone are abbreviations and Latinisms. The content, media, carrier fields in MARC (336, 337, 338) allow for the recording

of codes representing these aspects of a work. This replaces the old 245|h fields (e.g., "video recording,"


