1. Approval of the minutes: Mary O'Grady and James Matias
2. Treasurer's Report: Stephen reported that our balance as of April 30 is \$2,237.33. Our income for April 2016 was \$408.90 in CATS dues and our expenses were \$237.58 for hospitality and the LILC. We collected \$65.00 at the Minecraft program, \$283.00 at the LILC raffle, and \$6.00 in new members.
3. President's Report: There was no SCLA meeting this month. Nick reminded the Board that EAP workshops can be counted as continuing education credits. Discussion of ongoing frustration and concern over how we collect money at programs and for new CATS members.

 - c. Annual meeting- December 1st at SCLS Auditorium. We will host a guest speaker named Eric Cole who is an IT security expert. Topics may include Internet security, privacy concerns, and identity theft.
 - d. Someone at the Minecraft program suggested a Raspberry Pi program but this may be a better topic for a TIF meeting
